<u>Free of charge</u>: The term "free of charge" does not mean that the Patent Holder (RFTC/RFTG Member Organization) is waiving all of its rights with respect to the essential patent. Rather, "free of charge" refers to the issue of monetary compensation; *i.e.*, that the Patent Holder (RFTC/RFTG Member Organization) will not seek any monetary compensation as part of the licensing arrangement (whether such compensation is called a royalty, a one-time licensing fee, etc.).
